Social Responsibility Agreement

Saw Mill Club and Saw Mill Club East are committed to providing our members, guests and employees with an environment that is as clean and safe as reasonably possible. The cooperation of our members is required to best achieve this goal. To that end, in consideration for access to Saw Mill Club and Saw Mill Club East and its equipment, programs, supplies, staff, services, locker rooms and other facilities (collectively the "Facilities"), we ask that you, and all other members named on your Membership Agreement (together "Member"), acknowledge and agree with Saw Mill Club and Saw Mill Club East (together "SMC") as follows:

- A.** Member understands that other members, guests and staff will have access to SMC. While SMC takes reasonable steps to insure the safety and sanitization of the equipment, programs, supplies, services and facilities, Member acknowledges that SMC cannot and does not guarantee that the facilities are germ/virus free (this includes but is not limited to COVID-19).
- B.** Member agrees:
 - 1. to not seek entry to or use of Facilities if Member feels sick or exhibit any of the signs or symptoms of COVID-19
 - 2. that Member may be denied access to and use of SMC unless Member truthfully confirms that he or she is well on every visit, does not have signs and symptoms of COVID-19, and has not knowingly been exposed in recent days to a person diagnosed with COVID-19
 - 3. to adhere to any health, safety, social distancing and protective guidelines established by SMC or the U.S. Centers for Disease Control, World Health Organization, New York State or other federal, state or local governmental agency. Member agrees to wear a face mask completely covering the nose and mouth in the Facilities at all times, including while exercising, and to practice social distancing by keeping at least six (6) feet between Member and other members and employees. Member also agrees to disinfect all equipment after his or her use and to keep his or her hands washed/sanitized while at SMC and not to enter any areas that may be closed off.
- C.** Member understands, acknowledges and agrees that access to and use of Facilities by Member is voluntary and that they involve inherent risks. As material consideration for access to and use of Facilities, Member agrees to specifically assume all risks of personal injury, illness and death, property loss and other damages including, without limitation, risks of contracting COVID-19 or other bacterial or viral illnesses, associated with fitness classes and equipment, sports exercise, all locker room facilities and fitness advisory services and all other Facilities, and Member hereby releases, waives, discharges and covenants not to sue SMC and its respective officers, directors, managers, owners, partners, employees and agents ("SMC Parties") for any and all claims, liabilities, losses, costs, damages and expenses that Member may have against any SMC Parties for any personal injury, illness or death, property loss or other damages connected to or arising out of the associated risks. Any dispute between Member and any of the SMC Parties under this Agreement will be resolved by arbitration in Westchester County, NY in accordance with the rules of the American Arbitration Association.

This Social Responsibility Agreement constitutes an amendment to, and does not replace, the Membership Agreement between SMC and the Member. Member has the full power and authority to bind himself or herself and all other members named in such Membership Agreement to this Agreement.

Signatures to this Agreement transmitted by electronic means (including facsimile transmission or electronic mail transmission of a portable document format document) or affixed as an electronic signature shall be deemed and treated as original signatures and shall be valid and effective to bind Member to this Agreement.
